WHEREAS, the Universal Declaration of Human Rights recognizes education as a fundamental right necessary for the growth of an individual and the development of society;

WHEREAS, Section 1 Article XIV of the 1987 Constitution of the Philippines provides that: "The State shall promote the right of all citizens to quality education at all levels of education and shall take appropriate steps to make such education accessible to all";

WHEREAS, Section 2 of the same Article also states, "The State shall establish and maintain a system of free public education in the elementary and high school levels";

WHEREAS, Republic Act No. 9155, otherwise known as "An Act Instituting a Framework of Governance for Basic Education, Establishing Authority and Accountability, Renaming the Department of Education, Culture, and Sports as the Department of Education, and for Other Purposes", requires the state to protect and promote the right of all Filipinos to quality and accessible education by providing free and compulsory education in the elementary level and free education in the high school level;

WHEREAS, the Department of Education, through DepEd Order No. 40, entitled: "Establishment, Merging, Conversion and Naming / Renaming of the Public Schools, and Separation of Public School Annexes in Basic Education", requires a Sangguniang Bayan Resolution supporting the establishment of a school, before it gives recognition to an independent public education institution;

WHEREAS, the establishment of Manuel I. Santos Senior High School as the 4th public senior high school in the Municipality of Taytay will be helpful to the parents and students to lessen the expenses of the enrollees for both Grades 11 and 12;

WHEREAS, in the establishment of Manuel I. Santos Senior High School, the Municipal Government of Taytay shall support the funding of the expenses of the operations of the school through the Special Education Fund (SEF) until such time the schools Miscellaneous and Other Operating Expenses (MOOE) is made available as mandated by the General Appropriations Act (GAA);

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby SUPPORTS AND INTERPOSES NO OBJECTION TO THE ESTABLISHMENT OF MANUEL I. SANTOS SENIOR HIGH SCHOOL IN TAYTAY, RIZAL.

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.


