WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, a TDC Resolution was approved last December 16, 2022 allocating a total of Php 178,461,471.00 for the 20% Development Fund from the projected NTA of Php 892,307,355.00;

WHEREAS, the Municipal Treasurer attested that the actual allocation for the National Tax Allotment of the Municipality of Taytay for 2023 is Php 893,138,760.00. Thus, 20% shall be Php 178,627,752.00 to be allocated to Development Fund;

WHEREAS, submitted to the Honorable August Body is TDC Resolution No. 2023 - 006 for approval and ratification;

WHEREAS, there is a need to appropriate the additional Php 166,281.00 from the actual NTA to have a correct allocation for the 20% Development Fund and to fund the priority programs of the Municipality of Taytay, to wit:

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, to APPROVE AND RATIFY THE TAYTAY DEVELOPMENT COUNCIL (TDC) RESOLUTION NO. 2023 - 006 ENTITLED: "A RESOLUTION ALLOCATING THE AMOUNT OF ONE HUNDRED SIXTY-SIX THOUSAND TWO HUNDRED AND EIGHTY-ONE PESOS (PHP 166,281.00) TO THE CURRENT AMOUNT OF ONE HUNDRED SEVENTY-EIGHT MILLION FOUR HUNDRED SIXTY-ONE THOUSAND FOUR HUNDRED SEVENTY-ONE PESOS (PHP 178,461,471.00) REPRESENTING THE 20% DEVELOPMENT FUND FY 2023".

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.


