WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Taytay as a Legislative body of the Municipality is empowered to review the supplemental appropriation of barangays in the manner prescribed by law;

WHEREAS, the Sangguniang Barangay of Sta. Ana submitted to the Sangguniang Bayan for purposes of review the following:

- ORDINANCE NO. 004 S. 2023: AN ORDINANCE APPROPRIATING THE AMOUNT OF FIVE MILLION FIFTY-ONE THOUSAND NINE HUNDRED THIRTY PESOS AND 10/100 (P 5,051,930.10) FROM THE 5% BRGY. DISASTER RISK REDUCTION & MANAGEMENT FUND (BDRRMF) TO MOTOR VEHICLES (FIRE TRUCK) AND CAB CHASSIS FOR TANKER
- ORDINANCE NO. 005 S. 2023: AN ORDINANCE APPROPRIATING THE SURPLUS OF DECEMBER CY 2022 AMOUNTING TO NINE MILLION FIVE HUNDRED FIFTY-TWO THOUSAND THREE HUNDRED EIGHTY-ONE PESOS AND 41/100 (P 9,552,381.41) FROM GENERAL FUND TO MAINTENANCE & OTHER OPERATING EXPENSES, BRGY. DISASTER RISK REDUCTION & MANAGEMENT FUND, CAPITAL OUTLAY AND PERSONAL SERVICES
- ORDINANCE NO. 006 S. 2023: AN ORDINANCE APPROPRIATING THE SURPLUS OF DECEMBER CY 2022 AMOUNTING TO TWO MILLION SIX HUNDRED FIFTY-THREE THOUSAND THREE HUNDRED FIVE PESOS AND 39/100 (P 2,653,305.39) FROM DEVELOPMENT FUND TO DEVELOPMENT FUND UNDER CONCRETE OVERLAY OF ROAD AT YNARES AVE. WITH DRAINAGE, CONCRETING OF SECONDARY ROAD BOUNDARY OF PUROK

4 & 5 WITH DRAINAGE SYSTEM, VARIOUS CONSTRUCTION MATERIALS  
AND PUROK 6 HALF COURT

ANA, TAYTAY, RIZAL, APPROPRIATING ORDINANCE NO. 004 S. 2023, ORDINANCE NO. 005 S. 2023 AND ORDINANCE NO. 006 S. 2023 OF BARANGAY STA. ANA.
