Support Staff	P 1,500.00 (per day)
Team Leader	P 1,500.00 (per day)
Member	P 1,000.00 (per day)

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE COMPENSATION OF OVERTIME SERVICES TO THE PERSONNEL OF THE OFFICE OF THE MUNICIPAL TREASURER OF THIS MUNICIPALITY WHO SHALL PERFORM ELECTION AND POST ELECTION DUTIES.


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
