WHEREAS, the administration of Rosario Ocampo Elementary School (ROES) requests for assistance in the immediate rehabilitation of the ROES Gym and the rough roads inside the school vicinity where most school related activities, alumni initiated programs, and different events in the Municipality are being held;

WHEREAS, the ROES Gym, based on the Municipal Engineering Office's inspection, is in need of re-roofing as some portions of the gym's roof are already worn out and have been leaking, causing inconvenience to the pupils, school staff and other users of the said gym during school and non-school related activities;

WHEREAS, the school gym will be frequently used by the students, teachers, and other faculty members for their school events and other extracurricular activities on a regular basis which has been the case for several years now as its location and space is one of the convenient options for such;

WHEREAS, the rough roads in the school vicinity are also in need of cementing, as they also cause inconvenience and hazard to everyone in the vicinity;

WHEREAS, the Local Government Unit of Taytay has insufficient funds for the cementing of the rough roads and major repair of the said school gym thus entails seeking the support of the Provincial Government in responding to the clamor and request of the alumni, teachers and parents of the pupils of Rosario Ocampo Elementary School;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby RESPECTFULLY REQUESTS THE

HONORABLE GOVERNOR NINA RICCI YNARES TO ALLOCATE FUNDS FOR THE NECESSARY REHABILITATION OF THE SCHOOL GYMNASIUM AND CEMENTING OF ROUGH ROADS IN THE VICINITY OF ROSARIO OCAMPO ELEMENTARY SCHOOL.
