WHEREAS, Section 447 (a)(1)(i) of the Local Government Code states that the Sangguniang Bayan shall, “Review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punong Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the Punong Barangay”;

WHEREAS, the Sangguniang Barangay Secretariat of Barangay Sta. Ana submitted to the Sangguniang Bayan for review the following:

- **EXECUTIVE ORDER NO. 001, s. 2023:** An Order Reorganizing the Barangay Sta. Ana Bids and Awards Committee, Its Secretariat, and Its Technical Working Group and for Other Purposes
- **EXECUTIVE ORDER NO. 002, s. 2023:** An Order Strictly Enforcing Ordinance 689 s. 2020 also known as an Ordinance Prohibiting the Sale, Manufacture in the Municipality of Taytay and Regulating the Use of Firecrackers and other Pyrotechnic Devices and Designating a Firecracker Zone in the Municipality of Taytay, Rizal and for Other Related Purposes

WHEREAS, the aforementioned statutes had undergone the review of the Committee on Rules, Resolutions, and Ordinances to check on the merits of the pronouncement from the Barangay's Local Government Unit;


WHEREAS, after a thorough discussion and deliberation, it was agreed upon by the Committee members to approve the said declaration as prescribed in the adopted Committee Report of the Committee on Rules, Resolutions, and Ordinances;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby APPROVES IN REVIEW THE BARANGAY EXECUTIVE ORDER NO. 001 AND BARANGAY EXECUTIVE ORDER NO. 002 OF BARANGAY STA. ANA.


