A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO ACCEPT THE DONATION OF AN AMBULANCE FROM THE PROVINCIAL GOVERNMENT OF RIZAL THROUGH THE HON. GOVERNOR NINA RICCI YNARES, FOR THE USE OF TAYTAYEÑO CONSTITUENTS DURING TIMES OF CALAMITIES AND GENERAL EMERGENCIES, AND FOR OTHER PURPOSES

WHEREAS, Section 5, Article II of the 1987 Constitution provides that the “*maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy*”;

WHEREAS, Section 17(b)(2)(iv) of Republic Act (“R.A.”) No. 7160, otherwise known as the Local Government Code of 1991, requires Local Government Units (“LGUs”) to implement basic services such as “*[s]ocial welfare services which include programs and projects on child and youth welfare, family and community welfare, women’s welfare, welfare of the elderly and disabled persons; community-based rehabilitation programs for vagrants, beggars, street children, scavengers, juvenile delinquents, and victims of drug abuse; livelihood and other pro-poor projects; nutrition services; and family planning services*”;

WHEREAS, Section 444(b)(1)(vi) of R.A. No. 7160, provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the Provincial Government of Rizal offered to donate an ambulance to the Municipal Government of Taytay for the benefit of its constituents;

WHEREAS, the Municipal Government of Taytay acknowledges that an additional ambulance will be vital in the provision of prompt and adequate response during times of natural disasters and general emergencies;

WHEREAS, in order to ensure the delivery of utmost *Serbisyong May Ngiti*, the acceptance of said donation is necessary;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO ACCEPT THE DONATION OF AN AMBULANCE FROM THE PROVINCIAL GOVERNMENT OF RIZAL THROUGH THE HON. GOVERNOR NINA RICCI YNARES, FOR THE USE OF TAYTAYEÑO CONSTITUENTS DURING TIMES OF CALAMITIES AND GENERAL EMERGENCIES, AND FOR OTHER PURPOSES.

RESOLVED FURTHER, that a copy of this Resolution shall be forwarded to the Office of the Municipal Mayor, and all concerned offices in the Municipal Government of Taytay.


