WHEREAS, the St. John the Baptist Parish Church Taytay in the Diocese of Antipolo was established by Franciscan missionaries in 1579 near the shores of Laguna de Bay to honor its patron saint, John the Baptist, and is considered one of the oldest stone churches outside Intramuros;

WHEREAS, due to recurrent flooding, Jesuit Fr. Pedro Chirino relocated the church to a higher spot on a hill named San Juan del Monte, where the parish still exists today;

WHEREAS, on January 27, 2024, the parish priest of SJBP, Fr. Pedrito Rabonza III announced that Pope Francis had granted the parish church the title of Minor Basilica, the first in the Province of Rizal;

WHEREAS, the designation of Minor Basilica is typically given based on a church's architecture, history, and known liturgy, or a combination of these characteristics;

WHEREAS, the declaration of the Pope to the 16th-century church as a minor basilica is an honor that only 23 churches have in the Philippines;

WHEREAS, the people of Taytay and the Local Government Unit spearheaded by Mayor Allan Martine S. De Leon, MPA and the 12th Sangguniang Bayan of Taytay partakes in this historic solemnization and recognition of St. John the Baptist Parish as a Minor Basilica;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby EXTENDS FELICITATIONS TO THE ST. JOHN THE BAPTIST PARISH CHURCH FOR ITS SOLEMN DECLARATION AND ELEVATION TO MINOR BASILICA.

RESOLVED FURTHER, that copies of this Resolution be furnished and forwarded to the Diocese of Antipolo and all concerned for their information.
