## **RESOLUTION NO. 364 series of 2024**

A RESOLUTION ACKNOWLEDGING THE TAYTAY MUNICIPAL TRICYCLE FRANCHISING AND REGULATORY BOARD RESOLUTION NO. 58 & 59 SERIES OF 2024 – "ACKNOWLEDGING THE EXISTING TWENTY (20) LINES (FRANCHISE) WITH BODY NO. 71 - 90 REQUEST FROM SBMTODA AND THE EXISTING SIXTY-FIVE (65) LINES (FRANCHISE) WITH BODY NO. 46 – 110 REQUESTED BY MERURSTODA TO PROVIDE SAFE CONVEYANCE FOR COMMUTERS TO OPERATE WITHIN THE ROUTES AND TERMINAL ALLOCATED FOR THEIR TRICYCLE **OPERATIONS"**

WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, Section 447 paragraph 3(vi) and Section 458 paragraph 3(vi) of the Local Government Code of 1991 conferred unto the Municipal Government through the Sangguniang Bayan the power to regulate and grant franchise;

WHEREAS, the operation of tricycles is the primary mode of transportation in many areas in this municipality, servicing the secondary roads and subdivisions, and their operations greatly affect not only the mobility of the riding populace but also the peace, order, safety and harmony of the various area wherein these tricycles operate;

WHEREAS, SBMTODA and MERURSTODA have requested for the issuance of proper documents acknowledging the existing twenty (20) Lines (Franchise) from 71 - 90, and existing sixty-five (65) Lines (Franchise) from 46 - 110, respectively;

WHEREAS, all the aforementioned lines are not new lines, and have been in operation for many years now as reflected in the Taytay Municipal Tricycle Franchising Regulatory Office (TMTFRO) and the Business Permit and Licensing Office online system but has not been provided with a copy of any TMTFRO or Sangguniang Bayan Resolution;

WHEREAS, for documentation and transparency purposes, a Sangguniang Bayan Resolution has been requested by the Taytay Municipal Tricycle Franchising and Regulatory Board (TMTFRB), and the concerned TODAs;

WHEREAS, both TODAs expressed their commitment to follow the rules and regulations governing tricycle operations within the Municipality of Taytay;

WHEREAS, the TMTFRB expressed no objection of this foregoing and have adopted TMTFRB Resolution No. 58 and 59 series of 2024 during their Board Regular Session;



NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby ACKNOWLEDGES THE TAYTAY MUNICIPAL TRICYCLE FRANCHISING AND REGULATORY BOARD RESOLUTION NO. 58 & 59 SERIES OF 2024 – "ACKNOWLEDGING THE EXISTING TWENTY (20) LINES (FRANCHISE) WITH BODY NO. 71 – 90 REQUEST FROM SBMTODA AND THE EXISTING SIXTY-FIVE (65) LINES (FRANCHISE) WITH BODY NO. 46 – 110 REQUESTED BY MERURSTODA TO PROVIDE SAFE CONVEYANCE FOR COMMUTERS TO OPERATE WITHIN THE ROUTES AND TERMINAL ALLOCATED FOR THEIR TRICYCLE OPERATIONS".
