NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby ADOPTS THE RELOCATION / STRUCTURAL SURVEYS OF ALL PUBLIC SCHOOLS IN TAYTAY, RIZAL UNDER DEPED TAYTAY SUB OFFICE AS PART OF THE OFFICIAL ARCHIVES OF THE MUNICIPALITY OF TAYTAY, RIZAL.
