RESOLVED FURTHERMORE, that this integration shall be carried out by the appropriate offices and committees responsible for the formulation and updating of the CDP, LDIP, and AIP, ensuring that the nutrition-related initiatives are aligned with the overall development priorities of the Municipality.

RESOLVED FURTHERMOST, that a copy of the LNAP 2023-2025 shall be archived in the Records Section of the SB Secretariat Office.

RESOLVED FINALLY, that copies of this Resolution shall be disseminated to all concerned departments, offices, and stakeholders, and the LNAP 2023-2025 shall be made readily available to the public for their information and guidance.
