Ana have complied with the budgetary requirements and general limitations provided in the Local Government Code; Budget does not exceed the estimated receipts or income of the Barangay; and the items for appropriation are not more than those provided by existing laws;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES IN REVIEW AND DECLARES THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF BARANGAY STA, ANA FY 2024 IN THE AMOUNT ELEVEN MILLION SIX HUNDRED NINETEEN THOUSAND EIGHT HUNDRED FIVE AND FIFTY CENTAVOS (PHP 11,619,805.50) UNDER SANGGUNIANG KABATAAN RESOLUTION NO. 64, S. 2023, OPERATIVE SUBJECT TO CONDITIONS.
