A RESOLUTION AUTHORIZING THE HON. ALLAN MARTINE S. DE LEON, MPA, MUNICIPAL MAYOR, TAYTAY, RIZAL TO ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE MUNICIPALITY, WITH THE DEPARTMENT OF HEALTH – CENTER FOR HEALTH DEVELOPMENT 4A (CALABARZON) REPRESENTED BY DIR. ARIEL I. VALENCIA, MD, MPH, CESO III, REGARDING THE HEALTH EMERGENCY ALLOWANCE FOR HEALTH CARE WORKERS AND NON-HEALTH CARE WORKERS OF THE TAYTAY MUNICIPAL HEALTH OFFICE AND JUNE V. ZAPANTA EMERGENCY HOSPITAL WHO RENDERED THEIR SERVICES DURING THE COVID-19 PANDEMIC

WHEREAS, Republic Act No. 11712 known as the *Public Health Emergency Benefits and Allowances for Health Care Workers Act* and its Implementing Rules and Regulations (IRR) provides for the payment of Health Emergency Allowance (HEA), to Health Care Workers and Non-Health Care Workers who rendered their services during the COVID-19 Pandemic;

WHEREAS, Section 5 of RA No. 11712 also mandates the grant of Health Emergency Allowance to eligible health workers for every month of their service during the state of public health emergency based on the risk exposure categorization;

WHEREAS, the DOH – Department of Budget and Management (DBM) issued Joint Administrative Order (JAO) No. 2023-0001, dated October 16, 2023 entitled: “*Guidelines on the Grant of Health Emergency Allowance to Public Health Care Workers (HCWs) and Non-HCWs During the State of Public Health Emergency Due to COVID-19*” to provide guidelines for a rationalized identification of eligible health facilities;

WHEREAS, the Municipal Government of Taytay, Rizal is an established government entity by virtue of RA 7160, or the Local Government Code of 1991 and its amendments, and holds ownership and exercises administrative control and supervision over the June V. Zapanta Emergency Hospital;

WHEREAS, the Taytay Emergency Hospital, the operational control of which is directly administered by the Municipal Health Office, Taytay, Rizal, is a public health facility, employing HCWs and Non-HCWs assigned at designated COVID-19 units, whose services are critically needed during and while the public health emergency persist, and thus eligible recipients of the grant for Health Emergency Allowance;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE HON. ALLAN MARTINE S. DE LEON, MPA, MUNICIPAL MAYOR, TAYTAY, RIZAL TO ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE MUNICIPALITY, WITH THE DEPARTMENT OF HEALTH – CENTER FOR HEALTH DEVELOPMENT 4A (CALABARZON) REPRESENTED BY DIR. ARIEL I. VALENCIA, MD, MPH, CESO III, REGARDING THE HEALTH EMERGENCY ALLOWANCE FOR HEALTH CARE WORKERS AND NON-HEALTH CARE WORKERS OF THE TAYTAY MUNICIPAL HEALTH OFFICE AND JUNE V. ZAPANTA EMERGENCY HOSPITAL WHO RENDERED THEIR SERVICES DURING THE COVID-19 PANDEMIC.

RESOLVED FURTHER, that the duly signed Memorandum of Agreement between the Municipality of Taytay, Rizal and the Department of Health – Center for Health Development 4A shall be ratified first by the Sangguniang Bayan before its full implementation.


RESOLVED FURTHERMORE, that the copies of this Resolution be furnished to all concerned for their information and appropriate action.
