WHEREAS, upon further review, the Sangguniang Kabataan of Barangay San Isidro have complied with the budgetary requirements and general limitations provided in the Local Government Code; Budget does not exceed the estimated receipts or income of the Barangay; and the items for appropriation are not more than those provided by existing laws;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES IN REVIEW AND DECLARES THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF BARANGAY SAN ISIDRO FY 2024 IN THE AMOUNT OF FIVE MILLION SIX HUNDRED TWENTY-SEVEN THOUSAND AND SEVEN HUNDRED FORTY-ONE PESOS (PHP 5,627,741.00) UNDER SANGGUNIANG KABATAAN RESOLUTION NO. 8, S. 2023, OPERATIVE SUBJECT TO CONDITIONS.
