WHEREAS, upon further review, the Sangguniang Kabataan of Barangay Muzon have complied with the budgetary requirements and general limitations provided in the Local Government Code: Budget does not exceed the estimated receipts or income of the Barangay; and the items for appropriation are not more than those provided by existing laws;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES IN REVIEW AND DECLARES THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF BARANGAY MUZON FY 2024 IN THE AMOUNT OF FOUR MILLION TWO HUNDRED NINETY-ONE THOUSAND SIXTY-FOUR PESOS AND 50/100 (PHP 4,291,064.50) UNDER SANGGUNIANG KABATAAN RESOLUTION NO. 6, S. 2023, OPERATIVE SUBJECT TO CONDITIONS.
