WHEREAS, CDP is a multi-year plan prepared by the Local Government Unit in order to promote the general welfare of its inhabitants and serve as guide for the planners and implementers in the effective delivery of services to its people;

WHEREAS, the CDP consolidates the program and projects designed to carry out the objectives of the fifth development sectors, social, economic, physical land use, environmental management, and institutional development and is observed to have answered the sentiments and aspirations of Taytayenños;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby **ADOPTS THE COMPREHENSIVE DEVELOPMENT PLAN (CDP) YEAR 2023 – 2028 OF THE MUNICIPALITY OF TAYTAY, RIZAL.**


