WHEREAS, Ordinance No. 752 s. 2022, An Ordinance Regulating the Application of all Entities for Tree Cutting, Trimming, Pruning, and/or Earth-Balling Permits and Licenses from the Department of Environment and Natural Resources Office within the Municipality of Taytay, Rizal, shall still be properly observed and this collaborative initiative with the Provincial Environment and Natural Resources shall complement with the implementation of the local ordinance;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby REQUESTS THE PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES OFFICE TO ASSIST THE LOCAL GOVERNMENT OF TAYTAY IN PROFILING TREES WITHIN THE MUNICIPALITY THAT MIGHT IMPOSE DANGER TO THE GENERAL PUBLIC OR MIGHT REQUIRE PROPER RESTORATION AND/OR MANAGEMENT.
