WHEREAS, the urban Municipality of Taytay, Province of Rizal is home to 386,451 people (as per PSA 2020) and is known to be the Garments Capital of the Philippines with its local *tianggian* driving hundreds of thousands of tourists every year;

WHEREAS, Taytay is located East of Metro Manila and serves as a gateway to the rest of Rizal and Southern Luzon, thereby becoming a major thoroughfare for public and private vehicles, and even for motorists and cyclists alike;

WHEREAS, the Department of Transportation have already communicated with the Local Government of Taytay the proposed construction of the MRT 4 in 2024, which will have three (3) stations in Taytay;

WHEREAS, the upcoming construction of the MRT and the continuously growing volume of visitors and passersby are contributing to the build-up of traffic in key areas in the municipality;

WHEREAS, the Municipality of Taytay is in need of technical assistance in the formulation of its own Traffic Management Plan that could help ease traffic, better the flow of vehicles, promote active transport, and ensure connectivity of local and national public transportation options;

WHEREAS, in an exploratory meeting between the Municipal Government of Taytay and representatives of the MMDA, it was confirmed that MMDA can provide technical assistance to LGUs even outside of Metro Manila, as part of its general mandate;



WHEREAS, the Municipal Government of Taytay is willing to work with the Metro Manila Development Authority and enter into a formal partnership in accomplishing its goal to formulate its Traffic Management Plan and improve traffic flow within the municipality;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby EARNESTLY REQUESTS THE METRO MANILA DEVELOPMENT AUTHORITY (MMDA) THROUGH ITS GENERAL MANAGER RET. P/COL. USEC. PROCOPIO G. LIPANA TO PROVIDE TECHNICAL ASSISTANCE TO THE LOCAL GOVERNMENT UNIT OF TAYTAY IN THE FORMULATION OF ITS TRAFFIC MANAGEMENT PLAN.
