WHEREAS, 16 of R.A. 7160 or the General Welfare clause of the Local Government Code of 1991 states “that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those, which are essential to the promotion of the general welfare”;

WHEREAS, Section 36 of the same Code points out the “Assistance to People’s and Non-Government Organizations - A local government unit may, through its local chief executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise, to such people’s and non-governmental organizations for economic, socially-oriented, environmental or cultural projects to be implemented within its territorial jurisdiction”;

WHEREAS, the Rizal Police Provincial Office (PPO), with the help of the Sangguniang Kabataan Federation of Rizal will be conducting Youth Summit 2024 on July 20, 2024 at Rizal Police Provincial Office, Camp MGen Licerio Geronimo Cabrera Road, Brgy. Dolores, Taytay, Rizal;

WHEREAS, the Kabataan Kontra Droga at Terorismo (KKDAT) Taytay, Philippine National Police (PNP) Taytay together with the SK Federation Office of Taytay, would like to send 8 participants to the said activity, namely; Emerlyn Mercano, Decann Tucong, Raymond Daniles, Alexis Iguis, Mitchie Dingal, Edcel Dela Paz, for Mural Paintings and Cielo Manlongat for Original Song Composition, and Purity Reimel for Spoken Word Poetry;

WHEREAS, the SK Federation, would like to request the Municipal Mayor for financial assistance amounting to Php 1,000.00 and an additional Php 1,000.00 cash allowance for each participant from Taytay, Rizal, with a total amount of Php 16,000.00 to support their participation and recognize their efforts in bringing honor to Taytay;
