ALLAN MARTINE S. DE LEON, MPA, TO ENTER INTO MEMORANDUM OF AGREEMENT, FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL, WITH PHILIPPINE BUSINESS FOR SOCIAL PROGRESS INC. (PBSP)
