WHEREAS, the Municipal Tourism Office of Taytay, Rizal submitted for adoption of this August Body the updated Tourism Development Plan of the Municipality of Taytay, Rizal for 2023-2025 as of July 2024;

WHEREAS, the current version of the Local Tourism Development Plan is an updated version of the May 2023 Plan to include new developments in the local tourism industry such as the elevation of the Parish of St. John the Baptist to a Minor Basilica and the new directional strategies of the new Municipal Tourism Office;

WHEREAS, Section 37 of the Republic Act No. 9593 otherwise known as the Tourism Act of 2009 states that “LGUs, in consultation with stakeholders are encouraged to utilize their powers under Republic Act No. 7160, otherwise known as the Local Government Code of 1991, to ensure the preparation and implementation of a tourism development plan, the enforcement of standards and the collection of statistical data for tourism purposes. They shall, in so far as practicable, prepare local tourism development plans that integrate zoning, land use, infrastructure development, then national system of standards for tourism enterprises, heritage and environmental protection imperatives in a manner that encourages sustainable tourism development”;

WHEREAS, a Tourism Development Plan (TDP) is intended to align the municipality’s tourism sector with focus on enhancing the Local Government Unit of Taytay, Rizal capacity to develop the tourism sector, defining the framework to direct the formulation of policies and design of programs to engage the private sectors, CSOs and other LGU agencies;


WHEREAS, there is a need to adopt the Tourism Development Plan of the Municipality of Taytay, Rizal as it will serve as a guide in planning for strategic actions, programs and projects to improve the tourism sector of the municipality;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby ADOPTS AND APPROVES THE TOURISM DEVELOPMENT PLAN (TDP) 2023-2025 OF THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.


RESOLVED FURTHER, that copies of this Resolution be furnished and forwarded to all concerned for their information and appropriate action.
