WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, Section 106 of the Local Government Code of 1991 provides that each Local Government Unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by the Sangguniang Bayan;

WHEREAS, the Taytay Development Council (TDC) shall assist the Sangguniang Bayan (SB) in setting the direction of development effort within the municipality;

WHEREAS, a TDC Resolution was approved last December 13, 2023 allocating a total of PhP 189,559,139.60 for the 20% Development Fund from the projected NTA of PhP 937,795,698.00;

WHEREAS, the Municipal Treasurer attested that the actual allocation for the National Tax Allotment of the Municipality of Taytay for 2024 is PhP 949,534,353.00. Thus, 20% shall be PhP 191,906,870.60 to be allocated to Development Fund;

WHEREAS, there is a need to appropriate the additional PhP 2,347,731.00 from the actual NTA to have a correct allocation for the 20% Development Fund and to fund the priority programs of the Municipality of Taytay;


RESOLVED FURTHER, that copy of this Resolution be furnished to all concerned for their information and appropriate action.
