WHEREAS, the Taytay Development Council (TDC) shall assist the Sangguniang Bayan (SB) in setting the direction of development effort within the municipality;

WHEREAS, there were several priority projects/programs/activities that need funds allocation to be implemented;

WHEREAS, after thorough deliberation, the members of the Taytay Development Council (TDC) approved to realign the amount of Fifteen Million Two Hundred Thousand Pesos (P 15,200,000.00) from PPAs under the 20% Development Fund;

RESOLVED FURTHER, that copy of this Resolution be furnished to all concerned for their information and appropriate action.


