WHEREAS, Section 2, Article XIV of the 1987 Constitution mandates the State to "[e]ncourage non-formal, informal, and indigenous learning systems, as well as self-learning, independent, and out-of-school study programs particularly those that respond to community needs";

WHEREAS, Section 16 of Republic Act ("R.A.") No. 7160, otherwise known as the Local Government Code states that, "[e]very local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Section 444(b)(1)(vi) of R.A. No. 7160, "[p]rovides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance";

WHEREAS, the partnership between the Philippine Business for Education, Inc. ("PBEd") and the Municipal Government of Taytay, Rizal aims to develop and implement sustainable development, youth employment, and lifelong learning. This is done through learning and developing work-related skills and mastering underlying knowledge and scientific principles to support self-employment;



WHEREAS, in order to ensure the expeditious implementation of said programs, the Municipal Government expressed its interest to partner with all accredited technical vocational institutions in the Municipality of Taytay, Province of Rizal;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños through prompt and utmost public service, this Sangguniang Bayan Resolution is being issued;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO SIGN AND ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH PHILIPPINE BUSINESS FOR EDUCATION, INC. REPRESENTED BY ITS EXECUTIVE DIRECTOR, JUSTINE B. RAAGAS, TO ENHANCE THE QUALITY OF EDUCATION AND PROMOTE SKILLS DEVELOPMENT AMONG THE YOUTH SECTOR IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.

RESOLVED FURTHER, that the duly signed Memorandum of Understanding with Philippine Business for Education, Inc. shall be ratified first by the Sangguniang Bayan before its implementation.

RESOLVED FURTHERMORE, that copies of this Resolution be furnished to all Offices concerned for their information and appropriate action.
