**A RESOLUTION RATIFYING THE TAYTAY DEVELOPMENT COUNCIL (TDC) RESOLUTION NO. 2024 - 008 ENTITLED: “A RESOLUTION ALLOCATING THE AMOUNT OF TWO HUNDRED THIRTY MILLION ONE HUNDRED TWENTY-FOUR THOUSAND TWO HUNDRED FORTY-SEVEN PESOS AND FOURTEEN CENTAVOS (PHP 230,124,247.14) REPRESENTING THE 20% DEVELOPMENT FUND FY 2025 TO FUND THE VARIOUS PRIORITY PROJECTS / PROGRAMS FOR THE MUNICIPALITY” AND APPROVING THE 20% DEVELOPMENT FUND FY 2025**

WHEREAS, Section 106 of the Local Government Code of 1991 provides that each Local Government Unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by the Sanggunian Bayan;

WHEREAS, the Taytay Development Council (TDC) shall assist the Sanggunian Bayan (SB) in setting the direction of development effort within the municipality;



WHEREAS, the 20% Development Fund for the fiscal year 2025 will finance various priority projects for the Municipality;

WHEREAS, the members of the Taytay Development Council convened to formulate, discuss and approve the 20% Development Fund FY 2025;

WHEREAS, based on the Program of Works of the projects requested by the different sectors, organizations and individual to the Local Chief Executive in which he prioritized, as well as the priority projects of the Five (5) barangays, the 20% Development Fund FY 2025 that was presented during the meeting has a total amount of Two Hundred Thirty Million One Hundred Twenty-Four Thousand Two Hundred Forty-Seven Pesos and Fourteen Centavos (Php 230,124,247.14);

WHEREAS, after some clarifications, amendments and thorough deliberations, the Taytay Development Council approved to allocate the said amount to fund the following programs / projects of the municipality, to wit:


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
