WHEREAS, the Principal III, Ms. Amihan R. Fenis, of Muzon National High School, in behalf of all the students, parents, teachers and personnel of the school, wrote a letter requesting for the consolidation of Muzon National High School into a single unified campus;

WHEREAS, the aforesaid school has buildings and rooms sparse around different locations namely: Ciudad Grande Subdivision, San Miguel Compound, Barangay Talipapa (wet market) and 4 borrowed classrooms from Muzon Elementary School that students and faculty members utilize;

WHEREAS, Muzon National High School currently caters to 2,414 Junior High School students and will eventually offer Senior High School program in the near future, thus the need for approximately 45-50 classrooms ideally in one consolidated campus;

WHEREAS, there is a Municipal Government owned vacant lot located at Ramos Compound, Brgy. Muzon, Taytay, Rizal under CAD Lot. 295 with land area of 23,898 sqm;

WHEREAS, the said more than two (2) hectare land in Ramos compound can be the source of the minimum of 5,000 to 8,000 square meters for the proposed consolidation of all the multi-location campuses of Muzon National High School;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby REQUESTS THE LOCAL CHIEF EXECUTIVE, MAYOR ALLAN MARTINE S. DE LEON, MPA, TO ALLOCATE A PORTION OF THE MUNICIPAL GOVERNMENT OWNED LOT LOCATED AT RAMOS STREET,

BARANGAY MUZON FOR THE CONSOLIDATION OF ALL MUZON NATIONAL HIGH SCHOOL CAMPUSES.
