WHEREAS, the Municipal Government of Taytay desires to open and maintain time deposit accounts with Philippine Veterans Bank - Taytay Branch;

WHEREAS, pursuant to Sangguniang Bayan Resolution No. 423, Series of 2024, the Municipal Mayor Hon. Allan Martine S. De Leon, MPA, Vice Mayor Sophia Priscilla L. Cabral, Municipal Administrator Atty. Aldrick Daven M. Mendoza, MPA, and Municipal Treasurer Herlito A. Basco, were authorized to sign for and on behalf of the Municipal Government of Taytay, all warrants drawn with the account corresponding to the Executive and Legislative Department maintained by the Municipal Government of Taytay with Philippine Veterans Bank;

WHEREAS, in relation to the above-mentioned time deposit accounts, there is a need to particularly designate two (2) signatories for accounts in the executive branch, namely: Municipal Mayor, Allan Martine S. De Leon, MPA or Municipal Administrator, Atty. Aldrick Daven M. Mendoza and Municipal Treasurer, Herlito A. Basco; and likewise particularly designate two (2) signatories for accounts in the legislative branch, namely: Municipal Vice Mayor, Sophia Priscilla L. Cabral, and the Municipal Treasurer, Herlito A. Basco;

WHEREAS, consistent with the goal of providing Serbisyon May Ngiti, the issuance of the Sangguniang Bayan Resolution to particularly designate the authorized signatories for the time


deposit accounts with the Philippine Veterans Bank - Taytay Branch will further strengthen the mission of this Municipality to provide prompt and utmost public service to all its inhabitants;
