


TDC RESOLUTION NO. 2024 – 009

**A RESOLUTION RECOMMENDING THE ADOPTION OF THE LOCAL DEVELOPMENT
INVESTMENT PROGRAM (LDIP) COVERING THE YEARS 2023 - 2028**

- WHEREAS,** section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;
- WHEREAS,** section 106 of the Local Government Code of 1991 provides that each Local Government Unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by the Sanggunian Bayan;
- WHEREAS,** the Taytay Development Council (TDC) shall assist the Sanggunian Bayan (SB) in setting the direction of development effort within the municipality;
- WHEREAS,** there is a need for the formulation of Local Development Investment Program (LDIP) CYs 2023-2028 for the development of this municipality in terms of social, economic, environment, administrative governance and by implementing the fundamentals of good governance;
- WHEREAS,** the Sanggunian Bayan (SB) should have to ratify the adoption of the Local Development Investment Program (LDIP) CYs 2023-2028;






