DE LEON, MPA, TO NEGOTIATE, SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH HARRIS MEMORIAL COLLEGE, INC., REPRESENTED HEREIN BY ITS ACADEMIC DEAN, DR. ELVIRA D. MERCADO, PHD, FOR CHILD CARE AND DEVELOPMENT PROGRAM IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES

WHEREAS, Section 2 of R.A. No. 12199, otherwise known as the “Early Childhood Care and Development System Act” mandates that, “[i]t is hereby declared the policy of the State to safeguard and promote the right of every child to holistic well-being, growth, and dedicated care, recognizing the age-appropriate stages of development. The State commits to creating nurturing environments for children that ensure a healthy and sustainable program for nutrition, age-appropriate development, and special protection-with full recognition of the nature of childhood, as well as the necessity to provide developmentally appropriate experiences to address their needs”;

WHEREAS, Section 4(a) of R.A. No. 8980, otherwise known as the “ECCD Act” states that, “[e]arly Childhood Care and Development (“ECCD”) System refers to the full range of health, nutrition, early education and social services programs that provide for the basic holistic needs of young children from birth to age six (6), to promote their optimum growth and development”;

WHEREAS, the Municipal Government of Taytay shall enter into a Memorandum of Agreement (“MOA”) with Harris Memorial College, Inc. to create a nurturing and safe environment where young people, can thrive, by providing Child Care and Development Program for all Taytayeno constituents;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayenos, the negotiation of MOA with Harris Memorial College Inc. will strengthen the mission of the Municipal Government to meet the needs of its residents;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO NEGOTIATE, SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH HARRIS MEMORIAL COLLEGE, INC., REPRESENTED HEREIN BY ITS ACADEMIC DEAN, DR. ELVIRA D. MERCADO, PHD, FOR CHILD CARE AND DEVELOPMENT PROGRAM IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.

RESOLVED FURTHER, that the duly signed Memorandum of Agreement shall be ratified first by the Sangguniang Bayan before its full implementation.

RESOLVED FINALLY, that a copy of this Resolution shall be furnished to the Office of the Municipal Mayor of Taytay, Rizal, and the Academic Dean of Harris Memorial College Inc. for their information and appropriate action.


