WHEREAS, the position of Municipal General Services Officer requires competence, integrity, and relevant experience to ensure efficient and transparent operations in accordance with existing laws, rules and regulations;

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the appointment of the Municipal Government Head-I of the Municipal General Service Office by the Municipal Mayor shall be subject to the concurrence of the majority of all members of the Sangguniang Bayan;

WHEREAS, Honorable Mayor Allan Martine S. De Leon, MPA, has appointed Mr. Emilio G. Solisa to the position of Municipal Government Head-I of the Municipal General Service Office, in accordance with the qualifications set by existing laws and Civil Service Commission rules and regulations;

WHEREAS, the Sangguniang Bayan, upon review of the credentials, qualifications and compliance with civil service laws and eligibility requirements, finds Mr. Emilio G. Solisa, qualified and competent to serve in said position;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby EXPRESSES THE CONCURRENCE OF THE SANGGUNIANG BAYAN TO THE APPOINTMENT OF MR. EMILIO G. SOLISA AS THE MUNICIPAL GOVERNMENT HEAD-I OF THE MUNICIPAL GENERAL SERVICE OFFICE OF THE MUNICIPALITY OF TAYTAY, RIZAL.


RESOLVED FURTHERMORE, that copies of this Resolution shall be furnished to the Civil Service Commission and all other concerned offices for their information and appropriate action.
