

WHEREAS, Honorable Mayor Allan Martine S. De Leon, MPA, has appointed Mr. Emilio G. Solisa to the position of Municipal Government Head-I of the Municipal General Service Office, in accordance with the qualifications set by existing laws and Civil Service Commission rules and regulations;

WHEREAS, the Sangguniang Bayan, upon review of the credentials, qualifications and compliance with civil service laws and eligibility requirements, finds Mr. Emilio G. Solisa, qualified and competent to serve in said position;


RESOLVED FURTHERMORE, that copies of this Resolution shall be furnished to the Civil Service Commission and all other concerned offices for their information and appropriate action.
