A RESOLUTION APPROVING IN REVIEW AND DECLARING THE REVERSION OF UNEXPENDED BALANCE OF FUNDS FOR THE PROPOSED MULTI-PURPOSE HALL AT SAN LORENZO RUIZ, SAN JUAN, TAYTAY, RIZAL IN THE AMOUNT OF ONE MILLION TWO HUNDRED THOUSAND PESOS (₱ 1,200,000.00) FROM THE 20% DEVELOPMENT FUND TO THE GENERAL FUND OF BARANGAY SAN JUAN, TAYTAY, RIZAL OPERATIVE

WHEREAS, Section 322 of the Local Government Code of 1991 states that, “balances of appropriations authorized in the annual appropriations ordinance shall revert to the surplus of the general fund at the end of the fiscal year and shall not thereafter be available for expenditure except by subsequent enactment. However, appropriations for capital outlays shall continue and remain valid until fully spent, reverted or the project is completed. Reversions of continuing appropriations shall not be allowed unless obligations therefore have been fully paid or otherwise settled. The balances of continuing appropriations shall be reviewed as part of the annual budget preparation and the Sanggunian concerned may approve, upon recommendation of the local chief executive, the reversion of funds no longer needed in connection with the activities funded by said continuing appropriations subject to the provisions of this Section”;

WHEREAS, the reason for the reversion of unexpended balance was the proposed project of San Lorenzo Ruiz did not materialize because the required Deed of Donation for the particular parcel of land was not obtained from the lot donor;

WHEREAS, it is imperative for the Sangguniang Bayan to approve the Barangay Ordinance No. 6 s. of 2025 of Barangay San Juan for the reversion of their unexpended balance;

WHEREAS, the Committee on Finance, Budget and Appropriation after reviewing the Reversion of Barangay San Juan recommends that it be declared operative;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to APPROVE IN REVIEW AND DECLARE THE REVERSION OF UNEXPENDED BALANCE OF FUNDS FOR THE PROPOSED MULTI-PURPOSE HALL AT SAN LORENZO RUIZ, SAN JUAN, TAYTAY, RIZAL IN THE

AMOUNT OF ONE MILLION TWO HUNDRED THOUSAND PESOS (₱ 1,200,000.00) FROM THE 20% DEVELOPMENT FUND TO THE GENERAL FUND OF BARANGAY SAN JUAN, TAYTAY, RIZAL OPERATIVE.


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
