WHEREAS, the Municipality of Taytay needs to ensure a steady and safe blood supply for its constituents;

WHEREAS, the Philippine Red Cross has offered its willingness to make available such safe blood supply requirement of the Municipality of Taytay;

WHEREAS, the Municipality of Taytay shall establish a Blood Subsidy Fund of Two Hundred Thousand Pesos (Php 200,000.00), which fund shall be renewed annually and shall be used exclusively for the procurement of safe and quality blood from the Philippine Red Cross which is intended only for the constituents of the Municipality;

WHEREAS, the Municipality of Taytay and the Philippine Red Cross have agreed to maintain an open, continuing and direct communication about the supply of safe and quality blood to the constituents of the Municipality;

WHEREAS, the Municipality of Taytay shall coordinate with the Philippine Red Cross in conducting periodic mass bloodletting / donation activities to secure and ensure the availability of blood supply for the constituents of the Municipality;

WHEREAS, the Philippine Red Cross shall inform blood service facilities personnel to release blood products (if available) upon presentation of endorsement letters duly signed by authorized signatories of the Municipality of Taytay;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE HONORABLE MAYOR ALLAN MARTINE S. DE LEON, MPA, TO ENTER INTO A MEMORANDUM OF


AGREEMENT WITH THE PHILIPPINE RED CROSS FOR A BLOOD SUBSIDY FUND IN THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (PHP 200,000.00).

RESOLVED FURTHER, that a copy of this Resolution including its attachments, be forwarded to all concerned offices for their information and appropriate action.

RESOLVED FURTHERMORE, that the duly signed Memorandum of Agreement with the Philippine Red Cross be ratified first by the Sangguniang Bayan before its full implementation.
