A RESOLUTION EARNESTLY REQUESTING HONORABLE MAYOR ALLAN MARTINE S. DE LEON, MPA, TO PUT TOGETHER A TECHNICAL WORKING GROUP TO CONDUCT A COMPREHENSIVE REVIEW OF THE CREATION OF NEW BARANGAYS IN THE MUNICIPALITY OF TAYTAY, RIZAL

WHEREAS, the Local Government of Taytay, has a population of 397,111 making it the 2nd biggest Municipality in the Province of Rizal next to the Municipality of Rodriguez;

WHEREAS, despite the huge population size, Taytay remains to have the smallest number of barangays among all the municipalities in the Province of Rizal;

WHEREAS, the proposal to subdivide existing barangays in the municipality has been brought out in previous municipal councils with the 12th Sangguniang Bayan being the most recent, proposing the separation of Lupang Arenda to its mother Barangay, Sta. Ana;

WHEREAS, in the final presentation of the recent updating of the municipality's Comprehensive Land Use Plan, one of the land use issues and concerns identified was the physical inaccessibility of government service facilities, which includes barangay halls - to most citizens;

WHEREAS, the barangay, being the most basic unit of the government, is supposed to be accessible;

WHEREAS, the Technical Working Group can help the local government unit make objective decisions on the matter by providing data and in-depth analysis of the positive and negative effects of the subdivision of existing barangay units;

WHEREAS, the Technical Working Group may gather the technical details that are necessary for decision-making such as, but is not limited to the following:

- a. Population size of barangays and computation of populations for possible creation of new units
- b. Metes and bounds of each of the barangays and proposed subdivisions

- c. Budget requirement of the Municipality and availability of funds to support the first year operation of a new barangay
- d. Any existing boundary issues amongst the barangays and/or with other municipalities;

WHEREAS, the Technical Working Group may be composed of representatives from the Office of the Mayor, the Municipal Planning and Development Office, the Municipal Budget Office, the Liga ng mga Barangay, and the Municipal Assessors Office;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby EARNESTLY REQUESTS HONORABLE MAYOR ALLAN MARTINE S. DE LEON, MPA, TO PUT TOGETHER A TECHNICAL WORKING GROUP TO CONDUCT A COMPREHENSIVE REVIEW OF THE CREATION OF NEW BARANGAYS IN THE MUNICIPALITY OF TAYTAY, RIZAL.

RESOLVED FURTHER, for the TWG to submit a copy of their recommendations to the Sangguniang Bayan for proper legislative action.


RESOLVED FURTHERMORE, that a copy of this Resolution be furnished to all associated offices and parties concerned for their information and appropriate action.
