DE LEON, MPA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) THROUGH THEIR REPRESENTATIVE, MR. BARRY R. CHUA, MD, REGIONAL DIRECTOR OF DSWD FO IV-A, FOR THE TRANSFER OF FUND UNDER SOCIAL PENSION PROGRAM FOR THE INDIGENT SENIOR CITIZEN IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL AND FOR OTHER PURPOSES**

WHEREAS, the Department of Social Welfare and Development (DSWD) as the lead agency for social protection is mandated to work towards the achievement of Improved capacity and opportunities of the poor, vulnerable, and disadvantaged individuals, families, and communities to enable them to improve their quality life;

WHEREAS, the Local Government Code of 1991 (Republic Act No. 7160) provides that local government units (LGUs) shall promote the general welfare of their constituents and work in close coordination with national government agencies to implement programs and services that benefit the community;

WHEREAS, Republic Act No. 11916 series of 2022 otherwise known as An Act increasing the Social Pension of Indigent Senior Citizens provides that “indigent senior citizens shall be entitled to a monthly stipend in the amount of not less than One Thousand pesos (Php 1,000.00) to support the daily subsistence and medical needs of senior citizens”;

WHEREAS, one of the modalities in implementing the program is through transfer fund to the Local Government Units (LGUs) and the stakeholders identified fund transfer to LGUs is an efficient and effective mechanism in implementing the social pension program for indigent senior citizen program in their respective LGUs;

WHEREAS, the transfer of funds to the LGU Taytay is in accordance with COA Circular No. 94-013 series of 1994 and applicable accounting and auditing rules observed by the Government;

WHEREAS, the Department of Social Welfare and Development Field Office IV-A, in connection with the distribution of social pension and liquidation of the transferred fund, shall ensure the coordination and conduction of meetings / orientation to the Local Government of Taytay, Rizal with regards to the Social Pension Program to ensure adequate understanding of the

program before the implementation and provide a list of eligible senior citizens social pension beneficiaries after validation activities;

WHEREAS, the Local of Government of Taytay, Rizal, in connection with the distribution of social pension and liquidation of the transferred funds, shall facilitate the preparation and approval of payroll of eligible beneficiaries to receive the social pension based on the approved master list issued by the DSWD IV-A and also to facilitate the release of the stipend of Social Pension beneficiaries on quarterly basis;

WHEREAS, for the past years, the Local Government of Taytay, Rizal has a good track record in implementing efficient mechanism in delivering cash pay-out to social pension beneficiaries up to the barangay level;

WHEREAS, the OSCA and/or MSWD shall mobilized the Senior Citizen Organization (SCO) and the Barangay officials to assist in the information dissemination of the schedule and venue of the Social Pension Payout;

WHEREAS, the Municipality of Taytay, Rizal recognizes the need to collaborate with the DSWD to effectively implement the Social Pension Program in the Municipality;

WHEREAS, it is deemed necessary and appropriate to authorize the Municipal Mayor to sign and enter into the said MOA on behalf of the Municipality of Taytay, Rizal to ensure the efficient execution of social pension program;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR ALLAN MARTINE S. DE LEON, MPA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) THROUGH THEIR REPRESENTATIVE, MR. BARRY R. CHUA, MD, REGIONAL DIRECTOR OF DSWD FO IV-A, FOR THE TRANSFER OF FUND UNDER SOCIAL PENSION PROGRAM FOR THE INDIGENT SENIOR CITIZEN IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL AND FOR OTHER PURPOSES.

RESOLVED FURTHER, that the duly signed Memorandum of Agreement (MOA) with Department of Social Welfare and Development (DSWD) Field Office IV-A shall be ratified first by the Sangguniang Bayan before its implementation.


RESOLVED FURTHERMORE, that the copy of this Resolution be furnished to all concerned offices for their information and appropriate action.
