WHEREAS, Memorandum Circular No. 2025-060 of the Department of the Interior and Local Government provides for the guidelines on the accreditation and selection of people's organization, non-governmental organization and the private sector who are duly organized and existing and operating in the Municipality of Taytay;

WHEREAS, the list of CSOs attached as "Annex A" were able to submit the necessary requirements to secure their accreditation;

WHEREAS, after careful study and review by the Members of the Committee on Accreditation of the Sangguniang Bayan, the various documents supporting the application of the additional CSOs included as "Annex A" have satisfactorily complied with all the requirements / criteria set forth by the above-stated Memorandum Circular;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby GRANTS THE APPLICATION FOR ACCREDITATION OF VARIOUS CIVIL SOCIETY ORGANIZATIONS (CSOs) SUBJECT TO APPLICABLE LAWS, RULES AND REGULATIONS ON THE MATTER.
