2. THE CONSTRUCTION OF THE TAYTAY MUNICIPAL AUDITORIUM - TO SERVE AS A VENUE FOR VARIOUS SOCIAL, CULTURAL, AND GOVERNANCE-RELATED PROGRAMS THAT BENEFIT THE CONSTITUENTS OF TAYTAY.
