DE LEON, MPA, TO NEGOTIATE, SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH UNIVERSITY OF RIZAL SYSTEM – COLLEGE OF COMPUTER STUDIES, REPRESENTED HEREIN BY ITS UNIVERSITY PRESIDENT, DR. NANCY T. PASCUAL, FOR A COMPREHENSIVE ICT LITERACY TRAINING FOR TIANGGE VENDORS IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES

WHEREAS, the Local Government Code of the Philippines provides that every local government unit shall exercise the powers expressly granted those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient governance, and those essential promotion to the general welfare;

WHEREAS, every local government unit shall endeavor to be self-reliant and continue exercising the powers and discharging the duties and functions currently vested upon them, and shall likewise exercise such other powers, functions and responsibilities necessary, appropriate or incidental to efficient and effective provisions of basic services to its constituents;

WHEREAS, Section 1 of R.A. No. 7165 states that, *“it is the policy of the State to give the highest priority to the adoption of measures for the total eradication of illiteracy. For this purpose, it shall encourage and nationalize the formulation of policies and the implementation of programs on non-formal, informal, and indigenous learning systems, as well as self-learning, independent, and out-of-school study programs particularly those that respond to community needs”*;

WHEREAS, the Municipal Government of Taytay shall enter into a Memorandum of Agreement (“MOA”) with University of Rizal System – College of Computer Studies (“URS-CCS”) to pursue strategies and effectively implement programs and services addressing the needs of Taytay Vendors from the community;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños, the negotiation of MOA with URS-CCS will strengthen the mission of the Municipal Government to meet the needs of its inhabitants;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO NEGOTIATE, SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH UNIVERSITY OF RIZAL SYSTEM – COLLEGE OF COMPUTER STUDIES, REPRESENTED HEREIN BY ITS UNIVERSITY PRESIDENT, DR. NANCY T. PASCUAL, FOR A COMPREHENSIVE ICT LITERACY TRAINING FOR TIANGGE VENDORS IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.

RESOLVED FURTHER, that the duly signed MOA between LGU Taytay and URS-CCS shall be ratified first by the Sangguniang Bayan before its full implementation.


RESOLVED FURTHERMORE, that copies of this Resolution be forwarded to the Office of the Municipal Mayor, and all concerned offices in the Municipal Government of Taytay.
