WHEREAS, Article II, Section 15 of the 1987 Philippine Constitution declares that *"The State shall protect and promote the right to health of the people and instill health consciousness among them"*;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that *"Every local government unit shall exercise the powers ... essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety ... and preserve the comfort and convenience of their inhabitants"*;

WHEREAS, Section 17(b)(2)(viii) of the same Code further mandates municipalities to provide *"clinics, health centers and other health facilities necessary to carry out health services"*;

WHEREAS, the Honorable June V. Zapanta Emergency Hospital is a vital health institution catering to the urgent medical needs of the residents of this municipality, but currently lacks an appropriate waiting area for patients, their families, and visitors, thereby causing discomfort and congestion within hospital premises;

WHEREAS, to be able to provide support to the Honorable June V. Zapanta Emergency Hospital, this August Body would like to humbly request from the Congresspersons of Akbayan Partylist, a waiting area that may serve as a safe, comfortable, and dignified space for hospital clients while availing of emergency medical services;


WHEREAS, the construction of a waiting area will promote the general welfare, ensure patient safety and comfort, and enhance the delivery of health services to the constituents of the municipality;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby HUMBLY REQUESTS AKBAYAN PARTYLIST THROUGH ITS HONORABLE CONGRESSPERSONS TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF AN OUTPATIENT WAITING AREA FACILITY AT THE HONORABLE JUNE V. ZAPANTA EMERGENCY HOSPITAL.


