WHEREAS, Section 443(b) of Republic Act ("R.A.") No. 7160 otherwise known as the Local Government Code of 1991 provides that the Municipal Mayor "*appoint a municipal administrator, a municipal legal officer, a municipal agriculturist, a municipal environment and natural resources officer, a municipal social welfare and development officer, a municipal architect, and a municipal information officer*";

WHEREAS, Section 443(d) of R.A. 7160 states that the heads of departments and offices "*shall be appointed by the Municipal Mayor with the concurrence of the majority of all the Sangguniang Bayan members, subject to civil service law, rules and regulations*";

WHEREAS, on January 2, 2025, Municipal Mayor Allan Martine S. De Leon, MPA, appointed Atty. Czarmaine Angeli T. Villalobos, MPA, to serve as the Municipal Legal Officer of the Municipal Government of Taytay, Province of Rizal;

WHEREAS, the Sangguniang Bayan of Taytay concurs with the appointment of Atty. Czarmaine Angeli T. Villalobos, MPA, as the Municipal Legal Officer of the Municipal Government of Taytay, Province of Rizal;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to EXPRESS THE CONCURRENCE OF THE MEMBERS OF THE SANGGUNIANG BAYAN NG TAYTAY TO THE APPOINTMENT OF ATTY. CZARMAINE ANGELI T. VILLALOBOS, MPA, AS THE MUNICIPAL LEGAL OFFICER OF THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL.


