WHEREAS, the Local Revenue Code of Taytay, Rizal mandates the renewal and payment of Business Permit and Licenses and that no Business Permit shall be issued without registration from the Department of Trade and Industry;

WHEREAS, due to increasing number of the business establishment in our Municipality, it is deemed necessary for the taxpayers to be given ample time for the settlement of their business permit and licenses to avoid unnecessary charges and penalties;

WHEREAS, the paying public, businesses and other entities were also encouraged to utilize and maximize the Electronic - Business One Stop Shop (e-B.O.S.S.) and the online registration for new / renewal of Business Permit that are already available to address the bulk of the registrants in the municipality;

WHEREAS, despite that the Sangguniang Bayan had required from all concerned departments and sections to provide a system of procedure in the filing of Business Permit and in the implementation of the processing of payment for the convenience of the paying public, businesses and other entities may not be able to pay the same within the original deadline;


WHEREAS, the payment of Business Permit and Licenses without penalties and surcharges is only up to January 20, 2025, thus it is necessary to extend the deadline to March 31, 2025;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, to GRANT EXTENSION FOR THE PAYMENT OF REGISTRATION FOR THE RENEWAL OF BUSINESS PERMIT AND LICENSES UP TO MARCH 31, 2025 WITHOUT PENALTIES AND SURCHARGES.


RESOLVED FURTHER, that copies of this Resolution be furnished to all offices concerned for their information and appropriate action.
