WHEREAS, the intersection along Highway 2000 Phase 1 and Phase 2 has been identified as a critical area prone to traffic congestion and may also cause vehicular accidents due to the high volume of vehicles passing through the area;

WHEREAS, a yellow box junction serves as an effective traffic management measure designed to prevent severe traffic jams by ensuring that vehicles do not obstruct the intersection, thereby promoting smoother traffic flow and enhancing road safety;

WHEREAS, the installation of a yellow box junction at the intersections of Highway 2000 would significantly benefit motorists and commuters by reducing traffic congestion and minimizing the risk of accidents;

WHEREAS, in a Traffic Management Plan commissioned by the Municipality of Taytay to the Metro Manila Development Authority Traffic Engineering Office in 2019, the placement of a yellow box in the proposed area was recommended;

WHEREAS, the Rizal Provincial Planning and Development Office, under the leadership of Arch. Herbert Jose, ENP, possesses the expertise and resources necessary to assess, design, and implement traffic management solutions, including the proposed yellow box junction;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby EARNESTLY REQUESTS THE RIZAL PROVINCIAL PLANNING AND DEVELOPMENT OFFICE THROUGH ITS HEAD, ARCH. HERBERT JOSE, ENP, FOR THE INSTALLATION OF A YELLOW BOX JUNCTION



AT THE INTERSECTION OF HIGHWAY 2000 PHASE 1 AND 2, AND THE INTERSECTION OF HIGHWAY 2000 PHASE 2, P. OCAMPO STREET AND APOLLO STREET.
