WHEREAS, Section 444(b)(1)(vi) of R.A. No. 7160, provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the Municipality of Taytay recognizes the various significant advocacies led by the Honorable Senator Joseph Victor G. Ejercito, especially in infrastructure, health, youth empowerment and housing programs for the Filipino people;

WHEREAS, in acknowledging the necessity of additional resources for the benefit of its constituents, the 12th Sangguniang Bayan of the Municipality of Taytay, Province of Rizal humbly requests to the Honorable Senator Joseph Victor G. Ejercito, the provision of financial assistance for the purchase of five (5) dump trucks for the use of the Municipal Government of Taytay;

WHEREAS, in order to properly perform the duties of the Municipal Government enshrining the principle of *Serbisyong May Ngiti*, the request for financial assistance is necessary;
