WHEREAS, Resolution No. 47 series of 2024, enacted by the Sangguniang Kabataan of Barangay San Isidro in this Municipality has appropriated the amount of Six Million Three Hundred Thirty-Four Thousand Nine Hundred Seventeen Pesos and Sixty Centavos (Php 6,334,917.60) as its Annual Budget for FY 2025;

WHEREAS, the Annual Budget of Sangguniang Kabataan of Barangay San Isidro FY 2025 as submitted was reviewed and evaluated by the Municipal Budget Officer and have recommended that it be declared operative subject to conditions set forth in the review letter hereto attached;

WHEREAS, upon further review, the Sangguniang Kabataan of Barangay San Isidro have complied with the budgetary requirements and general limitations provided in the Local Government Code; Budget does not exceed the estimated receipts or income of the Barangay; and the items for appropriation are not more than those provided by existing laws;

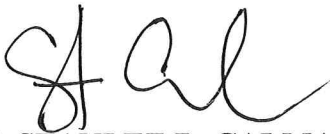
