WHEREAS, Resolution No. 73 series of 2024, enacted by the Sangguniang Kabataan of Barangay San Juan in this Municipality has appropriated the amount of Seventeen Million Three Hundred Fifty Thousand Pesos (Php 17,350,000.00) as its Annual Budget for FY 2025;

WHEREAS, the Annual Budget of Sangguniang Kabataan of Barangay San Juan FY 2025 as submitted was reviewed and evaluated by the Municipal Budget Officer and have recommended that it be declared operative subject to conditions set forth in the review letter hereto attached;

WHEREAS, upon further review, the Sangguniang Kabataan of Barangay San Juan have complied with the budgetary requirements and general limitations provided in the Local Government Code; Budget does not exceed the estimated receipts or income of the Barangay; and the items for appropriation are not more than those provided by existing laws;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES IN REVIEW AND DECLARES THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF BARANGAY SAN JUAN FY 2025 IN THE AMOUNT OF SEVENTEEN MILLION THREE HUNDRED FIFTY THOUSAND PESOS (PHP 17,350,000.00) UNDER SANGGUNIANG KABATAAN RESOLUTION NO. 73 SERIES OF 2024, OPERATIVE, SUBJECT TO CONDITIONS.

RESOLVED FURTHER, that Sangguniang Kabataan of Barangay San Juan shall strictly comply with the conditions set forth in the review and recommendation letter dated November 27, 2024 of the Municipal Budget Officer which shall form an integral part of this Resolution.
