WHEREAS, the national laws and policies that need to be incorporated to the existing Children's Code of the Municipality of Taytay are those updated provisions from newly enacted laws that pertain to the protection, education and the well-being of children;

WHEREAS, the Sangguniang Bayan of Taytay, Rizal, recognizes the significance of adopting the LCPC Resolution No. 01, series of 2025, to institutionalize these amendments and further promote the best interests of children;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby ADOPTS THE LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC) RESOLUTION NO. 01, SERIES OF 2025, ENTITLED: "A RESOLUTION FOR THE AMENDMENT OF THE CHILDREN'S WELFARE CODE OF THE MUNICIPALITY OF TAYTAY, RIZAL".
