De Leon and the 12th Sangguniang Bayan fully supports the championing of education thru the establishment of an added school in the Municipality of Taytay, Rizal to be known as Taytay-San Isidro National High School;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby SUPPORTS THE ESTABLISHMENT OF TAYTAY-SAN ISIDRO NATIONAL HIGH SCHOOL.
