WHEREAS, the Office of Punong Barangay of Barangay Muzon submitted to the Sangguniang Bayan for review a copy of Barangay Ordinance #8 s. 2025 entitled: "An Ordinance Enacting the Clearance Code of Barangay Muzon, Taytay, Rizal" and Barangay Ordinance #9 s. 2025 entitled: "An Ordinance Mandating the Requirements for Accreditation of Barangay Based Non-Government Organization (NGOs) and their Membership in the Barangay-Based Institution (BBIs)";

WHEREAS, the aforementioned statutes has undergone the review of the Committee on Rules, Resolutions, and Ordinances to check on the merits of the pronouncement from the Barangay's Local Government Unit;

WHEREAS, after a thorough discussion and deliberation, it was agreed upon by the Committee members to approve the said ordinances as prescribed in the adopted Committee Report of the Committee on Rules, Resolutions, and Ordinances;
