WHEREAS, the OGP Localization Program aims to bring these principles to the local government level to strengthen good governance at the grassroots;

WHEREAS, participating in OGP Localization enables the Local Government Units (LGUs) and Civil Society Organizations (CSOs) to work together to co-create and implement local action plans for a more open and responsive government;

WHEREAS, the Local Government Unit of Taytay, Rizal is one of the few selected Local Government Units included in the first group of the PH-OGP localization;

WHEREAS, the Local Government Unit of Taytay, Rizal firmly believes in the importance of participatory governance and intends to strengthen the relationship between the government and its citizens;

WHEREAS, the Local Government Unit of Taytay, Rizal by participating in this initiative, will engage with a global network and participate in peer learning to accelerate governance reforms;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to EXPRESS ITS FIRM INTENTION TO ACTIVELY PARTICIPATE IN THE PHILIPPINE - OPEN GOVERNMENT PARTNERSHIP (OGP) LOCALIZATION INITIATIVE.

RESOLVED FURTHER, that the Local Chief Executive of the Local Government Unit of Taytay, Rizal Honorable Allan Martine S. De Leon, MPA, is hereby authorized to execute the necessary documents and coordinate with national agencies, such as the DILG and DBM, to implement this intent.

RESOLVED FINALLY, that copies of this Resolution be sent to the Office of the DILG, and other relevant agencies for their information and appropriate action.
