WHEREAS, the Office of the Barangay Secretary of Barangay San Juan submitted to the Sangguniang Bayan for review a copy of Barangay Ordinance No. 05 s. 2025 entitled: “An Ordinance Granting Additional Benefits and Privileges to Senior Citizen from Seventy-Five (75) Years of Age and Above and Providing Funds Thereof”;

WHEREAS, the aforementioned Ordinance has undergone the review of the Committee on Social Services to check on the merits of the pronouncement from the Barangay’s Local Government Unit;

WHEREAS, after a thorough discussion and deliberation, it was agreed upon by the Committee members to approve the said Ordinance as prescribed in the adopted Committee Report of the Committee on Social Services;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby APPROVES IN REVIEW THE BARANGAY ORDINANCE NO. 05 S. 2025 OF BARANGAY SAN JUAN, TAYTAY, RIZAL.


